

OFFICIAL RULES

Da Sweepstakes

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE ODDS OF WINNING

- 1. PROMOTION PERIOD:** Da Sweepstakes (“**Promotion**”) begins at 8:00 AM Central Time (“**CT**”) on September 1, 2026, and ends at 11:59 PM CT on September 28, 2026 (the “**Promotion Period**”).
- 2. SPONSOR AND ADMINISTRATOR:** For purposes of these “**Official Rules**”, “**Sponsor**” shall mean the Illinois Department of the Lottery, which is acting through Allwyn Illinois LLC (“**Administrator**”) in its capacity as the private manager or its successor designated by the Sponsor. The Promotion is administered by the Administrator.
- 3. AGREEMENT TO THE OFFICIAL RULES:** By participating in the Promotion, all entrants (each an “**Entrant**” and collectively, “**Entrants**”) fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor and Administrator as final and binding in all matters related to the Promotion. Winning the Prize (defined below) is contingent upon fulfilling all requirements set forth herein.
- 4. HOW TO ENTER:** To enter the Promotion (each an “**Entry**” and collectively, “**Entries**”), Entrants must log into their account on the official Illinois Lottery application (“**Lottery App**”) or IllinoisLottery.com. Entrants who do not have a Lottery App or IllinoisLottery.com account must first create a free account to log in and enter. After Entrants have logged into their Lottery App or IllinoisLottery.com account, they must go to the Sweepstakes page on the Illinois Lottery website (<https://www.illinoislottery.com/sweepstakes>), select the Promotion, read and agree to these Official Rules, then click the “**Enter Now**” button during the Promotion Period. Afterwards, Entrants will receive an automated email, verifying their entrance into the Promotion. Sponsor and the Administrator are not responsible for entries that are incomplete or inaccurate. Limit one (1) Entry per person.

The Promotion computer, as determined in Administrator’s sole discretion, is the official timekeeping device for the Promotion. Sponsor, Administrator, and The Chicago Bears Football Club, Inc. (“**Chicago Bears**”) assume no responsibility for lost, mutilated, late, stolen, or misdirected Entries.

- 5. ODDS:** Odds of winning the Prize (defined below) set forth in Section 7 of these Official Rules depend on the total number of eligible Entries received during the Promotion Period.
- 6. ELIGIBILITY:** The Promotion is open only to individuals who, at the time of Entry, are at least eighteen (18) years of age and are residents of the State of Illinois. In addition, the following persons are not eligible to enter this Promotion or claim a Prize: (a) the employees, officers,

directors, partners, equity holders, members, and agents of the Administrator; (b) any member of the Lottery Control Board (“**Board**”), and any officer or any other person employed by the Board or the Sponsor; (c) the employees, officers, directors, partners, equity holders, members, and agents of the Chicago Bears; (d) officers and employees of advertising, public relations, and sales promotion agencies employed by the Sponsor or Administrator who are directly involved in the Illinois Lottery engagement; (e) officers and employees of audit firms performing services for the Sponsor; (f) other contractors and agents of the Sponsor; and (g) any spouse, child, or family member residing as a member of the same household in the principal place of residence of any person designated in (a) through (f). This Promotion is void where prohibited by law.

7. THE PRIZE AND ITS VALUE:

One (1) Prize: One (1) Prize winner (the “**Prize Winner**”) will receive four (4) tickets, one (1) for the Prize Winner and three (3) for his or her guests (the “**Guests**”), for the Bears 2026 regular season home game vs. the New England Patriots at Soldier Field, in Chicago, Illinois, on October 22, 2026 (the “**Game**”) (seat locations at the Game shall be determined in the sole discretion of the Chicago Bears); four (4) pre-game on-field passes prior to the Game (timing and access shall be determined in the sole discretion of the Chicago Bears); one (1) parking pass (location of the parking at the Game shall be determined in the sole discretion of the Chicago Bears), and one (1) Six Hundred Dollar (\$600) Fanatics gift card (gift card to be redeemable at Chicago Bears Pro Shop or online); (collectively, the “**Prize**”). All Prize details not explicitly mentioned in these Official Rules shall be determined at the sole discretion of Administrator and Chicago Bears. The approximate retail value (“**ARV**”) of the Prize is \$5,026.00.

The dates and times of the Promotion may be subject to change and cancellation. In the event that the Game or any part of a Game is cancelled, postponed or preempted for any reason, including weather, no rain checks, exchanges, substitution or cash replacement value of the Prize will be provided except at Sponsor’s or Administrator’s discretion. The Prize Winner and Guests agree to comply with all applicable venue rules and policies in connection with the Prize. Additional terms, restrictions, and exclusions may apply to each element of the Prize; see front and back of Game tickets and <https://www.chicagobears.com/tickets/terms-conditions> for additional terms and exclusions. All Game tickets are subject to verification and are void and will be rejected if not obtained through authorized, legitimate channels, or if any part of any Game ticket is determined by the Chicago Bears or Chicago Bears’ agent or representative (including but not limited to a Chicago Bears employee or contractor) to be illegible, forged, reproduced, manipulated, mutilated, counterfeited, or tampered with in any way, or if Game ticket contains printing, typographical, mechanical, or other errors.

In the event Prize Winner and/or their Guests engage in behavior during a Game or from the effective date of these Official Rules, make any comments in a social media format containing material that is inappropriate, offensive, indecent, obscene, hateful, tortious, defamatory, slanderous, or libelous or that (as determined by Sponsor, Administrator, the Chicago Bears, the National Football League (“**NFL**”), or an opposing team or its agents, in their sole discretion) is obnoxious or threatening, illegal, or that is intended to threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or customer goodwill of Sponsor, Chicago Bears, the NFL, Administrator or any of their owners, employees, services, products, trademarks, service marks, or logos, Administrator and/or Chicago Bears reserve the

right to terminate Prize redemption or eject the Prize Winner and/or their Guests from the Game with no further obligations or compensation whatsoever to Prize Winner and/or Guests (which may, in Administrator's sole discretion, result in such Prize Winner's disqualification from the Promotion and forfeiture of the Prize). In the event Prize Winner and/or their Guests engage in behavior during the Game that (as determined by Chicago Bears in its sole discretion) is illegal, tortious, or subjects Prize Winner or Guests to arrest or detention, the Released Parties (defined below) shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by Prize Winner and/or Guests as a result of such conduct. The Released Parties (defined below) are not responsible for acts of God, acts of terrorism, civil disturbances, work stoppage, or any other natural disaster outside their control that may cause the cancellation or postponement of the Promotion, and/or the fulfillment of any Prize. All other expenses and costs, not expressly listed above, including, but not limited to, federal, state, and local taxes, parking, and ground transportation are the winners' sole responsibility. All travel risks, insurance, loss, or damage due to Prize acceptance or use are the sole responsibility of the Prize Winner. THE RELEASED PARTIES SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF PRIZE WINNER'S AND/OR ANY GUESTS' ATTENDANCE AT THE GAME OR ANY OTHER ASPECT OF PRIZE WINNER'S AND/OR ANY GUESTS' ACCEPTANCE OR USE OF ANY PRIZE. For the avoidance of doubt, the Released Parties will not be responsible for any loss, liability, or damage arising out of a Prize Winner's acceptance or use of the Prize or any element thereof.

8. WINNER SELECTION AND NOTIFICATION TO PRIZE WINNER: The Prize Winner will be randomly selected from the pool of eligible Entries received during the Promotion Period on or around September 29, 2026. The Administrator will contact the potential winner(s) on or around September 30, 2026 ("**Promotion Notification Date**") and provide instructions on how to claim the Prize ("**Prize Notification**"). The Prize Notification will be sent to the email address provided in the potential winner's Lottery App or IllinoisLottery.com account. The potential winner(s) will be required to execute and return the Promotion Prize claim form ("**Claim Form**"), either in person or via email, and release of liability and publicity, unless prohibited by law, in order to claim the Prize. The potential winner(s) will have the length of time set forth in the Claim Form to claim his or her Prize. The Administrator or Administrator's designee will send the ticket portion of the Prize to the email address provided in the potential winner's Lottery App or IllinoisLottery.com account via Ticketmaster or similar digital means. The remaining elements of the Prize (e.g., parking, pre-game on-field passes, and gift card) will be provided by the Chicago Bears to the Prize Winner. By entering, the potential winner(s) consents to being contacted by the Administrator, Administrator's designee, the Chicago Bears, and/or Sponsor in connection with the Prize Notification. The Sponsor, Administrator, and Administrator's designee will not be liable for any delays in the receipt of Prize Notification messages.

If any potential winner does not respond to the Prize Notification within the time period set forth in the Claim Form or declines the Prize for any reason, disqualification and Prize forfeiture will result, and at Administrator's sole discretion and time permitting, an alternate potential winner will be randomly selected from the pool of eligible Entries received during the Promotion Period until a Prize Winner is selected.

The potential winner(s) is subject to verification of identity and eligibility prior to the award of the Prize.

9. GENERAL PRIZE RESTRICTIONS: The Prize is subject to availability and change. Only one (1) Prize Winner per household will be allowed during the Promotion Period. If due to a printing, production or other error more prizes are claimed than are intended to be awarded, the intended Prize will be awarded in a random drawing from among all verified and validated Entries. The Prize will be subject to the Sponsor's debt setoff procedures. Specifically, to the maximum extent permitted by applicable law, the Sponsor shall determine if the potential winner(s) has an outstanding debt to the State of Illinois or any city or county within Illinois, owes delinquent taxes, or is past due on child support. If any debt is discovered, the potential winner(s) will be disqualified. The Administrator will notify the potential winner(s) of their disqualification. No substitution or cash redemption allowed by winner(s). No cash equivalent of the Prize will be awarded, and the Prize is not exchangeable or otherwise transferable. Administrator reserves the right to substitute the Prize in whole or in part with other prizes of comparable or greater value, if the intended prize is not available for any reason, as determined by the Administrator in its sole discretion. Transportation and lodging are not included. The Prize Winner and their Guests will be exclusively and solely responsible for travel to and the costs thereof, and all other costs and expenses associated with Prize acceptance and use not described as being provided, including but not limited to taxes, gratuities, incidentals, transportation costs, and other expenses incurred by accepting a Prize. This Promotion is governed by and shall be construed in accordance with Illinois law, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws and is subject to all applicable federal, Illinois, and local laws and regulations. Any and all taxes, including but not limited to federal, state, and local taxes, are the exclusive and sole responsibility of the Prize Winner. The Prize Winner may be required to provide his or her Social Security number and appropriate tax documentation for tax reporting purposes. If required, the Sponsor, Administrator, or a designee will file an IRS Form 1099 or similar document with the Internal Revenue Service for the fair market value of any Prize.

10. GENERAL CONDITIONS AND RELEASE: The Promotion is subject to applicable laws and regulations. By entering, each Entrant (a) agrees to defend, indemnify, release, and hold harmless the Sponsor, the Chicago Bears, the NFL Entities (defined below), and the Administrator (collectively, the "**Promotion Entities**"), and each of their respective owners, parents, affiliates, subsidiaries, directors, officers, agents, employees, managers, licensees, distributors, dealers, retailers, printers, representatives, advertising and promotion agencies, and any and all other companies associated with the Promotion, and all of their respective officers, directors, employees, agents, and representatives (collectively with the Promotion Entities, the "**Released Parties**") from and against any and all claims, causes, costs, injuries, losses, or damages of any kind that may occur, directly or indirectly, in whole or in part, arising out of the Entrant's and/or their Guests' participation in this Promotion or receipt or use of any Prize, including, but not limited to: (i) unauthorized human intervention in the Promotion; (ii) technical errors related to computers, servers, providers, or telephone or network lines; (iii) printing errors; (iv) lost, late, postage-due, misdirected, or undeliverable mail; (v) errors in the administration of the Promotion or the processing of Entries, including but not limited to data entry errors resulting from or caused by the entering, keying, or mis-keying of the required information by entrants; (vi) injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from Entrant's

participation in the Promotion or receipt or use of any element of the Prize; (vii) the unauthorized or illegal access to personally identifiable or sensitive information or the acceptance, possession, use, or misuse of any Prize or any travel or activity related to the receipt or use of any Prize; (b) if selected as the Prize Winner, consents to the use by Sponsor, Administrator, Chicago Bears, and each of their respective designees of the Prize Winner's name, hometown, photograph, voice, or other likenesses and Prize information for promotion, advertising, and marketing purposes in any media or format now known or hereafter devised, throughout the world, in perpetuity, without additional compensation, consideration, notification, or permission, unless prohibited by law, and upon request will provide written confirmation of such consent; and (c) acknowledges that none of the Released Parties or anyone else has either made, or is in any manner responsible or liable for, any warranty, representation, or guarantee, either expressed or implied, in fact or in law, relative to any aspect or portion of the Prize including but not limited to, its quality or availability and ALL SUCH WARRANTIES ARE DISCLAIMED IN THEIR ENTIRETY. **"NFL Entities"** is defined as the National Football League, its member professional football clubs, NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, NFL Productions LLC and NFL International LLC and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees.

None of the Released Parties or any of their service providers are responsible for incorrect or inaccurate transcription of Entry information; any human or other error, technical malfunctions; lost or delayed data or voice transmission; omission; interruption; deletion; defect; line failures of any telephone network, computer equipment, or software; inability to access any online service or website or to complete a telephone call or facsimile transaction; any other error or malfunction; late, lost, or misdirected mail; or any injury or damage to an Entrant's or any other person's computer related to or resulting from participation in this Promotion.

None of the Released Parties are responsible for or liable for: (a) late, lost, damaged, misdirected, misaddressed, incomplete, unintelligible, or illegible entries; (b) telephone, electronic, hardware or software program, network, internet or computer malfunctions, failures or difficulties of any kind; (c) failed, incomplete, garbled, or delayed computer transmissions; (d) any condition caused by events beyond their control that may cause the Promotion to be disrupted or corrupted; (e) any injuries, losses, or damages of any kind arising in connection with or as a result of the Promotion, acceptance, possession, or from participation in the Promotion; (f) any printing or typographical error in any material associated with the Promotion; (g) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, wireless service, mail, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties that may occur in connection with the administration of the Promotion, the processing of entries, the announcement of the Prize, or in any Promotion-related materials; or (h) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion.

Sponsor and Administrator reserve the right, in their sole discretion, to cancel the Promotion in its entirety, if it becomes technically corrupted or because of non-authorized human intervention. If any discrepancy should exist between these Official Rules and any promotional material describing this Promotion, these Official Rules shall govern.

CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEBSITE ASSOCIATED WITH THIS PROMOTION, TAMPER WITH THE ENTRY PROCESS, OR OTHERWISE UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THE PROMOTION MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, ADMINISTRATOR WILL DISQUALIFY ANY SUCH ENTRANT, AND ADMINISTRATOR AND THE APPLICABLE PROMOTION ENTITIES AND THEIR RESPECTIVE AGENTS RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH ENTRANT OR INDIVIDUAL(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

No failure to enforce any term of these Official Rules shall constitute a waiver of that provision. These Official Rules may be modified for clarification purposes without materially affecting the terms and conditions of the Promotion. If for any reason the Promotion (or any portion thereof) is not capable of being executed as planned, or in the case of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures, or any other causes that, in the opinion of Sponsor or Administrator, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion (or any portion thereof), Sponsor and Administrator reserve the right in their sole discretion to disqualify any suspect Entry or Entrant and/or to cancel, terminate, modify, or suspend the Promotion (or any portion thereof). Any Entrant that enters the Promotion via a fake account (e.g., bot account) will be disqualified. In the event of any disqualification of a suspect Entry or Entrant, notice thereof will be posted and the determination of the Prize Winner will be made from among all eligible, non-suspect Entries received as of the time of such disqualification, as Sponsor or Administrator determine in their sole discretion. Entrants not complying with all rules are subject to disqualification. In the event of any termination, cancellation, or suspension, notice thereof will be posted on the Sponsor's website.

11. APPLICABLE LAWS: All Entrants agree to comply with and abide by all applicable laws, including the Illinois Lottery Law (20 ILCS 1605/1 *et seq.*), administrative rules and regulations, instructions, conditions and final decisions of the Sponsor and all procedures established by Sponsor and the Administrator for the Promotion. In the event of a conflict between these Official Rules and any summary, representation, or other restatement of rules appearing in any advertisement, point of sale material, lottery tickets, or other media, these Official Rules shall govern. In the case of a conflict or contradiction between or among the Illinois Lottery Law, Illinois Lottery administrative rules (11 Ill. Admin. Code Parts 1700 and 1770), and these Official Rules, the Illinois Lottery Law and administrative rules shall control. The Sponsor does not waive sovereign immunity rights provided under law and nothing in these Official Rules shall be interpreted to constitute a waiver of the Sponsor's sovereign immunity rights.

12. DISPUTE RESOLUTION: Except where prohibited by law, by entering, Promotion Entrants agree that in the event of a dispute concerning the construction, validity, interpretation, or enforceability of these Official Rules, the determination of the Sponsor shall be final and binding. Any Entrant who disputes a final decision of the Sponsor may seek review before an Administrative Law Judge pursuant to Section 7.3 of the Illinois Lottery Law. In accordance with the Illinois Lottery's hearing rules (11 Ill. Admin. Code Part 1700), the Director will review the

recommendation of the Administrative Law Judge and, if applicable, the Board, and issue a final decision regarding the dispute. Any party adversely affected by a final decision or order of the Director may obtain judicial review as provided by the Illinois Lottery's hearing rules and Administrative Review Law (735 ILCS 5/Article III). All issues and questions concerning the rights and obligations of participant(s) in relation to Sponsor, Administrator, and their agents shall be governed by and construed exclusively in accordance with the laws of the State of Illinois without giving effect to any principles of conflicts of law of any jurisdiction. Entrant agrees that any such action at law or in equity shall be filed only in the state or federal courts located in Chicago, Illinois, and Entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. EXCEPT WHERE PROHIBITED BY LAW, BY PARTICIPATING IN THIS PROMOTION, EACH ENTRANT AGREES THAT: (A) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS PROMOTION, OR AWARDING OF THE PRIZES, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS ASSOCIATED WITH PARTICIPATING IN THIS PROMOTION BUT IN NO EVENT ATTORNEYS' FEES; AND (C) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN AWARDS FOR AND HEREBY WAIVES ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL, CONSEQUENTIAL, MULTIPLIED OR OTHERWISE INCREASED DAMAGES; AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES.

13. E-MAIL COMMUNICATION: By entering this Promotion, Entrants will automatically be signed up to receive e-mail communication from the Illinois Lottery. Entrants will have the ability to unsubscribe from these e-mails upon receipt.
